

## **2021 ANNUAL CUP MATCH CLASSIC RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT**

The Annual Cup Match Classic is a hallmark of Bermudian culture and observes an essential time in Bermuda's history. It is the time of year that Bermudians of all walks of life look forward to as an occasion to reflect, rejoice and have a good time. Our goal at the St. George's Cricket Club is to maintain the cultural and historical legacy of this event while providing a festive atmosphere for all to enjoy.

As hosts of the 2021 Annual Cup Match Classic the health and safety of our players, staff, and fans remain our top priority. We are working to keep you safe so that you can have a safe and enjoyable Cup Match.

**Please read carefully before purchasing a ticket to the 2021 annual Cup Match Classic ("Cup Match" ). This document has legal consequences and will affect your legal rights and ability to bring future legal actions.**

### **COVID PROTOCOLS:**

The Cup Match Classic 2021 is a Safe Key event. The following protocols must be adhered to by all attendees:

1. Safe Key will be used to admit all participants. This includes all players, officials, audience, staff, and vendors.
2. All participants must either show proof of vaccination or evidence of a negative test 72 hours before admission. Please have hard copies of your test results and/or vaccination card available along with your Safe Key.
3. Children under the age of two (2) will not be required to have a negative COVID-19 test to be admitted when accompanied by an adult.
4. All attendees must enter the grounds wearing a face mask. Removal of masks and facial coverings is only allowed while actively eating or drinking.
5. Immunized persons must wear masks also as it is a mass gathering.
6. **NO OUTSIDE ALCOHOL PERMITTED ON THE PROPERTY** (You are only permitted to bring swizzle in a clear or transparent container).

**By purchasing an entry ticket or by entering the grounds of St. George's Cricket Club for Cup Match,**

1. **I confirm that I have read the Covid Protocols as set out herein;**
2. **I willingly agree to comply with the stated and customary terms and conditions for participation.**
3. **I acknowledge and accept that I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of others, and assume full responsibility for my participation in Cup Match.**

**I HEREBY AGREE TO HOLD HARMLESS, DEFEND, AND INDEMNIFY EACH OF THE RELEASEES FROM ANY LOSS, LIABILITY, CLAIM, DAMAGE, JUDGMENT, LEGAL FEES, OR COSTS ARISING FROM OR INCURRED DUE TO MY PARTICIPATION IN OR OTHERWISE IN CONNECTION WITH THE EVENT, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, TO THE FULLEST EXTENT PERMITTED BY LAW;**
